The Pre-amble

Research dealing with human subjects as well as those related to Environmental and scientific conduct is guided by international rules and regulations the most important being the World Medical Association Declaration of Helsinki. The declaration quotes numerous other documents that deal with ethical handling of human subjects. World Health Organization (WHO) recommends the formation of Ethical Review Committees (ERCs) at Regional, National and Institutional level and has provided guidelines for ERCs. It is in this context that Pwani University (PU) constituted the ERC in order to provide guidance to Pwani University Ethical Review Committee to review and clear biomedical Research proposals.

PWANI UNIVERSITY ETHICS REVIEW COMMITTEE OPERATIONAL GUIDELINES

Review Process

- (i) Submitted proposals will be received by the secretary of the ERC.
- (ii) The ERC will acknowledge receipt of submitted proposal to the applicants or research bodies.
- (iii) Each proposal will be assigned two reviewers whose recommendations will be discussed in an ERC general meeting.
- (iv) The reviewed proposals will be documented in a database of records (soft and hard copies).
- (v) The general meeting will procedurally adopt the recommendations and approve. The ERC decisions will be under seal and authenticated by the Chairperson, Secretary and lay member appending their signatures.
- (vi) The reviewed proposals shall be sent back with ERC recommendations to the applicants or research bodies within 21 days.

The decisions of the ERC will not be made public, but communicated to the applicant through a letter of decision accompanied by a Certificate of Approval upon acceptance by the applicant, the conditions of approval given by the ERC.

ROLES OF PU-ERC

- Review and clear proposed research before its commencement
- Provide independent, competent and timely review of the ethics of proposed studies.
- Review prospective and continuing research protocols
- Take into consideration the principle of iustice.
- Review adequacy of Informed consent
 document
- Regular evaluation of ethics of ongoing studies that received positive decision.
- Evaluate reports for unanticipated problems, non compliance and other information, that might affect approval of the protocol or subject's willingness to continue to participate.
- Act in the interest of potential research participants and concerned communities, taking into account the interests and needs of the researchers and having due regard for the requirements of the relevant regulatory agencies and applicable laws

SUBMITTING APPLICATION

Application for proposed ethics review for biomedical research must be submitted by a qualified research team responsible for the ethical and scientific conduct of the research.

Application requirements

- Names and addresses of the ERC secretariat to whom application material is to be submitted.
- Appropriate documentation (Research Proposal, Researchers CVs and/or questionnaires, informed consent, layman summary)
- The language in which document will be submitted will be English

• Application fee shall be determined by PU-ERC from time to time (refer to Table below).

Approval Conditions

Approval shall be given for a specified period – If project takes longer than specified period, then a request for an extension of the ethics clearance shall be sought

Approval shall be given on conditions that any alterations proposed to the approved protocol are submitted to the committee for approval prior to alterations being effected

Approval shall be given on condition, that a copy of research project final report will be submitted to ERC for its information

Approval shall be given subject to researchers notifying the ERC if and when the project is curtailed, terminated or completed.

Approval shall be given for therapeutic trials subject to the Principal Investigator (PI) notifying ERC within 7 days (A week) of any adverse events or occurrence that takes place during that trial.

Research may be audited by PU – ERC during research period to ensure compliance with guidelines
